THREE WAYS TO QUALIFY

RANK ADVANCEMENT



- 1 Reach the rank of Executive Manager for the first time and qualify for activities, dinner and accommodation for 1 person.
- 2 If you reach the Executive Manager rank for the first time, hold it for at least 1 additional month, you will then qualify for activities, dinner and accommodation for 2 people.
- 3 Achieve at least the rank of Director for the first time and qualify for activities, dinner and accommodation for 2 people.



RANK MAINTENANCE*
